**AMENDED ORDER**

This Order amends Miscellaneous Order Number 07-09, which was filed February 6, 2007, and Miscellaneous Order Number 11-0004-24, which was filed December 19, 2011.

Pursuant to the authority of 18 U.S.C. 3563(b) and 18 U.S.C. 3583(d), regarding terms of probation and supervised release and the mandatory and discretionary conditions of supervision, it is ordered that the following sex offender conditions are hereby adopted and promulgated as standard sex offender conditions in the United States District Court for the District of New Mexico:

**STANDARD SEX OFFENDER CONDITIONS FOR ALL SEX OFFENSES IN THE DISTRICT OF NEW MEXICO**


1. You must undergo a sex offense-specific assessment to determine the level of risk for sexual dangerousness, recidivism, and amenability to treatment and formulate treatment recommendations if treatment is necessary. You may be required to pay all, or a portion of the cost of the assessment.
2. You will waive your right of confidentiality and allow the treatment provider to release treatment records to the probation officer and sign all necessary releases to enable the probation officer to monitor your progress. The probation officer shall disclose the presentence report and/or any previous sex offender or mental health evaluations to the treatment provider.
3. You must submit to a search of person, property, residence, vehicles, documents, businesses, computers [as defined in 18 U.S.C. 1030(e)(1)], and other electronic communications or data storage devices or media effects, at any time, by a probation officer with reasonable suspicion concerning a violation of a condition of probation or supervised release, or unlawful conduct by the person, in the lawful discharge of the officer's supervision functions. You must inform any other occupants that the

premises may be subject to searches pursuant to this condition. Failure to submit to a search may be grounds for revocation of supervision.

4. You will not have any direct or indirect contact or communication with the victim or his or her family, or go near or enter the premises where the victim or his or her family resides, is employed, attends school or treatment, except under circumstances approved in advance and in writing by the probation officer.
