Attorneys appointed to the Auxiliary Panel will handle misdemeanor and material

witness matters. Attorneys appointed in a criminal matter must perfect an appeal if requested by

the client to do so. The Tenth Circuit will determine counsel on appeal. All terms expire on

December 31st on the year listed.
