

IT IS FURTHER ORDERED that GREGORY B. WORMUTH, as a full-time Magistrate Judge, shall hold and discharge the duties of the office for a term of eight (8) years from the effective date of this appointment, subject to the provisions of 28 U.S.C. § 631(i), unless sooner relieved.
