

**IT IS FURTHER ORDERED** that BARBARA SMITH EVANS, as part-time Magistrate Judge, will hold and discharge the duties of her office for a term of four (4) years from the effective date of her appointment, subject to the provisions of 28 U.S.C. § 631 (i), unless sooner relieved.
