ADMINISTRATIVE ORDER

PURSUANT to the provisions of the Criminal Justice Act, 18 U.S.C. §§3006(a)(1) and (c), the Office of the Federal Public Defender for the District of New Mexico and qualified members of the Criminal Justice Act Panel, are hereby appointed to represent defendants previously determined to have been entitled to appointment of counsel, to determine whether or not an individual defendant may qualify to seek resentencing or a reduction in sentence and to present any motions or applications for resentencing under 28 U.S.C. § 2255 based on a retroactively applicable United States Supreme Court decision or for a sentence reduction under 18 U.S.C. § 3582 based on a retroactively applicable amendment to the United States Sentencing Guidelines.

Federal Public Defender and Criminal Justice Act panel attorneys who were previously appointed to represent defendants will be reappointed to investigate and pursue claims for their clients. In the event a former or current panel attorney is no longer available to provide such representation or wishes to decline this representation, the Office of the Federal Public Defender is hereby appointed to represent that client previously represented by Criminal Justice Act panel attorney. Should the Office of the Federal Public Defender determine that there is a conflict with regard to the representation of a particular defendant, the Court shall appoint another member of the Criminal Justice Act panel of this Court.
