SUPPLEMENTAL ADMINISTRATIVE ORDER

WHEREAS, this Court continues to evaluate its response to the spread of COVID-19 and in order to provide additional information to litigants and prospective jurors, this Administrative Order modifies certain portions of Administrative Order 20-MC-00004-17. The justification for this Supplemental Administrative Order is the same as for Administrative Order 20-MC-00004-17.

IT IS HEREBY ORDERED that, effective immediately, all civil and criminal jury trials scheduled to commence now through July 6, 2020 before any judge in any courthouse in the District of New Mexico are **CONTINUED** subject to further order of the presiding judge.

IT IS FURTHER ORDERED that effective immediately, in accordance with the Centers for Disease Control and Prevention (“CDC”) guidelines and the New Mexico Department of Health (“DOH”) [Public Health Emergency Order](#) of May 15, 2020, all persons entering courthouse facilities (as permitted by Administrative Order 20-MC-00004-17) are required to wear a face mask.

IT IS FURTHER ORDERED that public and media access to court hearings will continue to be live-streamed as outlined in the [COVID-19 Temporary Administrative Procedures Manual](#).

All other terms of Administrative Order 20-MC-00004-17 continue to remain in effect through May 29, 2020.
