IT IS FURTHER ORDERED that effective immediately, in accordance with the Centers for

Disease Control and Prevention ("CDC") guidelines and the New Mexico Department of Health ("DOH")

Public Health Emergency Order of May 15, 2020, all persons entering courthouse facilities (as permitted by

Administrative Order 20-MC-00004-17) are required to wear a face mask.

IT IS FURTHER ORDERED that public and media access to court hearings will continue to be

live-streamed as outlined in the COVID-19 Temporary Administrative Procedures Manual.

All other terms of Administrative Order 20-MC-00004-17 continue to remain in effect through May

29, 2020.
