ADMINISTRATIVE ORDER

This Order supersedes Administrative Order 20-MC-00004-42.

WHEREAS, the Court recognizes that the steadily rising number of COVID-19 cases in the State of New Mexico and surrounding areas has the potential to adversely affect those who enter any of the federal courthouses within the District of New Mexico.

WHEREAS, the recent State of New Mexico Public Health Emergency Order dated December 2, 2020, authorized and approved by the Governor of New Mexico implementing travel and dining restrictions, creates logistical challenges for grand jurors who live more than 100 miles from Albuquerque or Las Cruces from being able to report for jury duty.

WHEREAS, this Court has suspended all civil and criminal jury trials in the District of New Mexico through January 31, 2021, the Supreme Court of the State of New Mexico has suspended all civil and criminal jury trials in the State Courts in New Mexico through the end of January 2021, and the United States Districts Courts for the Districts of Utah, Colorado, and West Texas have or will soon likewise suspend all civil and criminal jury trials at least through the end of January 2021.

IT IS HEREBY ORDERED that effective immediately all grand jury proceedings in the District of New Mexico are SUSPENDED through January 31, 2021.
