**SUPERSEDING ADMINISTRATIVE ORDER**

**WHEREAS**, the Court continues to evaluate its response to the spread of Coronavirus Disease 2019 (COVID-19) and in order to provide authoritative information to litigants and prospective jurors, this order supersedes Administrative Order 21-MC-00004-42;

**WHEREAS**, the Centers for Disease Control and Prevention (“CDC”) has issued [revised guidelines](#), as of July 27, 2021, in response to the Delta variant of the Coronavirus.

**IT IS HEREBY ORDERED** that, effective immediately, in accordance with CDC guidelines and the New Mexico Department of Health (“DOH”) Public Health Emergency Order of June 30, 2021, all persons entering courthouse facilities, regardless of vaccination status, are required to wear a face mask in public settings in court facilities. Mask wearing requirements in courtrooms, conference rooms and chambers will be established by the presiding judge.

**IT IS FURTHER ORDERED** that, while the CARES Act enabling orders of this court, Administrative Order 21-MC-00004-25 and Administrative Order 21-MC-00004-26, are in effect, public and media access to court hearings will continue to be live-streamed, at the discretion of the presiding judge, according to procedures located on the [court’s website](#).

This administrative order will remain in effect until otherwise ordered by the court.
