ORDER ESTABLISHING CJA PANEL OF ATTORNEYS

THIS MATTER comes before the court pursuant to 18 U.S.C. § 3006A and § 5 of the

CJA Plan for the District of New Mexico adopted by the court in 2015. This order is effective

January 1, 2022, and as of its date of effectiveness it supersedes all previously entered orders

establishing the CJA Panel of Attorneys. The court has reviewed the applications for

membership on the CJA Panel, has considered the recommendations of the CJA Panel

Committee, and orders as follows.

The attorney listing is divided by division (Albuquerque, Las Cruces, and Roswell). The

listed attorney is appointed for the CJA panel(s) and term specified after their name. Alternative

language abilities for each attorney are listed as well. The panels include the **General Felony** 

Panel, the Complex Case Panel, the Appeal and Habeas Corpus Panel, and the Auxiliary

Panel.

Attorneys appointed to the **Auxiliary Panel** will handle misdemeanor, supervised release

revocation, Rule 5/Rule 32.1 matters and material witness matters. Attorneys appointed in a

criminal matter must perfect an appeal if requested by the client to do so. The Tenth Circuit will

determine counsel on appeal. All terms expire on December 31<sup>st</sup> on the year listed.
