

**IT IS FURTHER ORDERED** that B. PAUL BRIONES, as a part-time Magistrate Judge, shall hold and discharge the duties of the office for a term of four (4) years from the effective date of this appointment, subject to the provisions of 28 U.S.C. § 631(i), unless sooner relieved.
