**PURSUANT** to the authority conferred by 28 U.S.C. § 631 et seq., and the further authority granted by the Judicial Conference of the United States.

**IT IS ORDERED** that JERRY H. RITTER is hereby appointed to serve as a full-time Magistrate Judge in the United States District Court for the District of New Mexico at the salary fixed by the Judicial Conference.

**IT IS FURTHER ORDERED** that JERRY H. RITTER shall enter upon the performance of the duties as United States Magistrate Judge on the 5<sup>th</sup> day of September, 2025, provided that prior to the commencement of such duties, he shall have taken the oath or affirmation prescribed by 28 U.S.C. § 453 and 631(g).

**IT IS FURTHER ORDERED** that JERRY H. RITTER as a full-time Magistrate Judge, shall hold and discharge the duties of the office for a term of eight (8) years from the effective date of this appointment, subject to the provisions of 28 U.S.C. § 631(i), unless sooner relieved.
