ADMINISTRATIVE ORDER

Nos. 25-MC-00004-28 and 25-MC-00027-03, concerning the matter addressing the Stay of Civil Cases Involving the United States, and pursuant to Paragraph 10 of the Order, the Court has been informed that appropriations have been restored to the Department of Justice, and the Court hereby lifts the stay order.
