ADMINISTRATIVE ORDER

THIS MATTER comes before the court pursuant to 18 U.S.C. § 3006A and § 5 of the CJA Plan for the District of New Mexico adopted by the court in 2015. In light of a growing immigration caseload that has stressed the current General Felony Panel beyond its capacity, the Court is expanding the authority of the Auxiliary Panel and amending, as follows, its Order Establishing CJA Panel of Attorneys, Misc. No. 25-MC-04-34 as to the types of matters assigned to the Auxiliary Panel.

Attorneys appointed to the Auxiliary Panel will handle misdemeanor, supervised release revocation, Rule 5/Rule 32.1, material witness, and 8 U.S.C. § 1326(a) immigration matters.

All other provisions of the Order Establishing CJA Panel of Attorneys, Misc. No. 25-MC-04-34 remain in effect.
