

**IT IS FURTHER ORDERED** that LOURDES A. MARTINEZ, as full-time Magistrate Judge, shall hold and discharge the duties of the office for a term of eight years from the effective date of this appointment, subject to the provisions of 28 U.S.C. § 631 (i), unless sooner relieved.
