**ORDER OF APPOINTMENT**

Upon recommendation of the Magistrate Judge Merit Selection Panel, the unanimous agreement of the District's Active Judges, under the authority conferred by 28 U.S.C. § 631, et seq., and the authority of the Judicial Conference of the United States,

**IT IS ORDERED** that STEPHAN M. VIDMAR is hereby appointed to serve as full-time Magistrate Judge in the United States District Court for the District of New Mexico at the salary fixed by the Judicial Conference.


**IT IS FURTHER ORDERED** that STEPHAN M. VIDMAR will enter upon the performance of the duties as United States Magistrate Judge on the 27<sup>th</sup> day of December, 2011; but prior to commencement of such duties, he will take the oath or affirmation prescribed by 28 U.S.C. §§ 453 and 5 U.S.C. § 3331.

IT IS FURTHER ORDERED that STEPHAN M. VIDMAR, as full-time Magistrate Judge, will hold and discharge the duties of his office for a term of eight (8) years from the effective date of his appointment, subject to the provisions of 28 U.S.C. § 631(i), unless sooner relieved.
